Students learn to set goals and solve problems using patience, communication skills, self-control, frustration tolerance, and motivational techniques while helping individuals with disabilities.

Team Training - A two-week course for clients and their personal care attendants consisting of lectures, dog handling drills and community field trips. To receive public access with their dogs, clients must pass a public access test created by Assistance Dogs International, a written final exam, and a solo skills test in a public setting.

Education regarding the importance of service dogs and disability awareness is provided to the public.
